(i) 2011 Tax Increase

Councillor Beffort referred to the Region of Peel budget increase of 2.5% and inquired how this would impact Caledon's budget since we were relying upon a 2.2% Regional increase.

Fuwing Wong, Treasurer advised that there are no changes required to the Town's budget as the 2.5% regional increase applies to Brampton and Mississauga. Caledon's regional increase is 2.2%.

Mayor Morrison advised that Caledon is lower due to the policing.
