1. Smoke Free By-law.

Paul Callanan, Director, Environmental Health Officer, Peel Public Health provided the following information:

Smoke-free Outdoor Spaces

Background

- Tobacco is still the leading cause of preventable disease and death in Ontario
- Outdoor second-hand smoke (OTS) is emerging as an issue in areas where smoking is still permitted (e.g. entrances to some buildings, some patios, outdoor playgrounds, sporting facilities, parks, beaches, etc.)

Why are we looking at this issue now?

- Recommendation from City of Mississauga Environmental Advisory Committee (EAC) to consider regional approach to address smoking near outdoor playgrounds and municipally owned buildings/facilities
- Bans have already been successfully implemented in several municipalities across Ontario

Why a by-law?

- Smoke-free by-laws...
 - Reduce exposure
 - Support those trying to quit smoking
 - Discourage others (especially youth) from starting to smoke
- Public attitudes support smoke-free outdoor spaces

Smoke-free Outdoor Spaces By-law Proposal

- Collaborative approach between Caledon, Brampton, Mississauga and Peel Region
- Report to Peel Regional Council July 7th
- Proposed By-law:
 - Smoking at outdoor public places be prohibited
 - Possible exemptions
- Proposed implementation May 31, 2012 (World No Tobacco Day)

NOTE: Members of Council indicated that it is important to look at solutions for assisting employees who smoke.

NOTE: It was suggested that employees who smoke be engaged in the consultative process.

Whereas Caledon Council received Report LS-2009-020 on September 15, 2009 regarding Graffiti Initiatives; and

Whereas the Town of Caledon is committed to keeping the Town green and clean; and

Whereas graffiti has a negative impact on our communities; and

Whereas as outlined in Report LS-2009-020 PACC applied for funding to create a program that would focus on graffiti removal but were not successful; and

Whereas graffiti on private property is addressed on a complaint basis and the property owner is responsible for removal; and

Whereas utility boxes are frequently a target of graffiti; and

Whereas Canada Post has initiated a pilot project to deter graffiti on post boxes by replacing the post boxes with already marked up post boxes that are not an attraction to taggers because they do not have a blank canvas for tagging; and

Whereas Canada Post has deployed 1500 Street Letter boxes nationally; and

Whereas Canada Post is currently expanding the program to include Vancouver, Ottawa and Toronto; and

Whereas the OPP has a graffiti eradication program;

Now therefore be it resolved that Council direct staff to arrange a meeting with representatives of the various utilities, the OPP, PACC and Region of Peel to develop a coordinated approach to proactively respond to incidents of graffiti; and

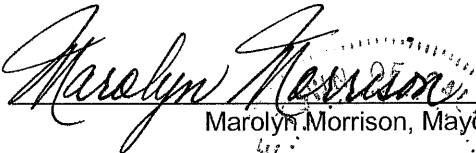
