Whereas the Town of Caledon's past practice of providing a "grace period" for the payment of property taxes ended on June 15, 2011; and

Whereas the Town notified taxpayers of the Town's revised late payment charges for the non-payment of property taxes via newspaper advertisements over several months, the Town's internet site, a pamphlet included with the final 2011 tax bill, and via the final tax bill itself; and

Whereas certain Town of Caledon property taxpayers incurred late payment charges for the August 30, 2011 tax installment following the "grace period" change;

Therefore be it resolved that Council enact a by-law to:

 provide the Treasurer or designate a one-time authorization to write-off late payment charges related to the late payment of the August 30, 2011 only property tax installment payment provided that the taxpayer qualifies for and enrolls in the Town's pre-authorized payment plan, on or before October 30, 2011, for a minimum of 3 years (commencing 2012 and ending in 2014); and

 authorize staff to add the late payment charges back onto the tax account should the taxpayer withdraw from the pre-authorized payment plan (PAP) or the pre-authorized plan be terminated by the Town for two missed PAP payments, prior to the last PAP in 2014.
