Small acts of violence are committed daily through attitude and intimidating behavior and these small acts add up to create an atmosphere of distrust, insecurity and fear. We must speak out against aggression towards women; and

Whereas, attitudes are changing and women no longer need to act alone against violence in our society. Governments, community groups, corporations, the media and others are more aware of the way violence isolates and harms women;

Therefore be it resolved that all citizens observe this day in commemoration of all women who are or have been victims of violence, and in remembrance of the victims of the Montreal Massacre; and

Further be it resolved that December 6, 2011 be proclaimed "National Day of Remembrance and Action on Violence Against Women" in the Town of Caledon.
