Whereas the Drummond Commission Recommendation 6-16 states "The Province should amend the Education Act to give school boards the power to charge modest transportation user fees set by the Province; and

Whereas the purpose of public education is to provide free public education to all grade school and high school students; and

Whereas the intent of Recommendation 6-16 is to allow school boards to charge a user fee for transportation; and

Whereas this will erode the principal of "free public education" in Ontario; and

Whereas transportation user fees will impact rural Ontario more than any other area of Ontario and therefore will be inequitable; and

Whereas a healthy vibrant rural economy is vital to Ontario and transportation user fees will impose a burden on rural workers and their families who must live in the countryside; and

Whereas the Province of Ontario mandates that children must attend school; and

Whereas it is unclear how such a user fee could be demanded given other Provincial legislation;

Therefore be it resolved that the Town of Caledon, as stewards of its community, forcefully reject any notion of user fees for school children for any purpose and specifically for transportation; and

Further be it resolved that this resolution be distributed to Premier McGuinty; the Peel school boards, AMO, ROMA, FCM and to Sylvia Jones, MPP.

Whereas a new land use shall comply with the Minimum Distance Separation (MDS) formulaes in the Provincial Policy Statement; and

3. Lyme Disease Awareness Month - May 2012.

Whereas, ticks carrying the bacteria Borrelia burgdorferi that causes Lyme Borreliosis, commonly known as Lyme disease continue to spread across Ontario and Canada; and

Whereas, the number of reported cases of Lyme disease in North America continues to increase, yet the Centers for Disease Control estimates that on average there are ten missed cases for every case reported; and

Whereas, Lyme disease is difficult to diagnose because it imitates other conditions and no reliable laboratory test can prove who is infected or bacterial-free, which often leads to misdiagnosis; and

Whereas, early indicators of infection include flu-like symptoms, characterized by chills, headache, fatigue, muscle and joint aches and swollen lymph nodes; and

Whereas, weeks or months later, patients with untreated or under-treated Lyme disease can suffer from serious, permanent and sometimes life-threatening damage to the brain, joints, heart, eyes, liver, spleen, blood vessels and kidneys. For this reason it is imperative that all who develop this disease receive immediate early treatment; and

Whereas, the best solution to the threat of Lyme disease is to educate people about the seriousness of the illness and the need to practice personal preventive techniques when engaging in outdoor activities, such as frequent tick checks, use of tick repellant and proper tick removal;

Therefore be it resolved that the month of May, 2012, be proclaimed "Lyme Disease Awareness Month" in the Town of Caledon to draw attention to this growing health problem and the importance of early detection and treatment by all residents.

Whereas over 80% of Canadians now live in urban areas and have come to rely on the environmental, ecological and economic benefits of urban forests; and

Whereas the health of Canadians is sustained by their urban forests which provide services through improving air quality, cooling city streets and buildings, acting as a windbreak, shading from harmful UV rays, and filtering storm water, as well as beautifying our communities; and

Whereas neither the federal nor provincial governments currently include urban forestry in their mandates except in a limited role with respect to exotic, invasive pests; and

Whereas the Canadian Food Inspection Agency has not been able to stop the spread of the Emerald Ash Borer throughout Ontario and Quebec; and

Whereas the Emerald Ash Borer is expected to cost Canadians over \$2 Billion dollars in treatment and replanting; and

Whereas Canadian forestry programs and research are solely focused on industrial forests and do not at present include urban tree planting, appropriate species research, and insect control and management; and

Whereas other jurisdictions such as the United States Forest Service and the European Urban Forestry Research and Information Centre include urban forestry as a program and research area; and

Whereas Canada engages municipalities in a number of substantial infrastructure programs;

Therefore be it resolved that The Town of Caledon calls on the Federal and Provincial governments to take leadership roles in recognizing the need to support urban forestry, by establishing urban forestry mandates and programs which includes funding assistance to municipalities for the control and management of the Emerald Ash Borer and any future significant imported diseases and insects -as well as the creation and funding of programs designed to support the on-going sustainable management of urban forests; and

Further be it resolved that all municipalities across Ontario be encouraged to endorse this proclamation and that this resolution be distributed to The Honourable Gerry Ritz, Minister of Agriculture and Agri-Food; The Honourable Joe Oliver, Minister of Natural Resources, The Honourable Denis Lebel, Minister of Transport, Infrastructure and Communities; The Honorable Jim Flaherty, Minister of Finance; Sylvia Jones, MPP,

Honourable Michael Gravelle, Minister of Natural Resources; Honourable Kathleen Wynne, Minister of Municipal Affairs and Housing; Honourable Dwight Duncan, Minister of Finance; David Tilson, MP, Tim Hudak, MPP, Leader of Progressive Conservative Party of Ontario and the Opposition Party; Andrea Horvath, MPP, Leader of the New Democratic Party of Ontario, Association of Municipalities of Ontario and Federation of Canadian Municipalities.
