Whereas a demolition permit application has been received from the Caledon East United Church for the c.1856 Caledon East Orange Lodge located on its property; and

Whereas the Orange Lodge is considered to be a significant built heritage resource as one of only two nineteenth century former Orange Lodge buildings

remaining in Caledon (Caledon East and Sandhill), and the only one that has not been structurally altered from its original use; and

Whereas when the potential demolition of the Orange Lodge was first raised in 2002 Heritage Caledon retained the Architectural Conservancy of Ontario to undertake a condition assessment of the building, which confirmed its architectural integrity, structural stability and potential for re-use; and

Whereas Heritage Caledon had subsequently recommended relocation and adaptive re-use of the Orange Lodge for meetings and other functions on the Town Hall campus in its 2003 Kerr Log House Adaptive Re-use Strategy; and

Whereas this recommendation was reiterated in the Caledon Heritage Foundation's 2007 Kerr Log House Redevelopment Feasibility Study received by Council in that year; and

Whereas the Orange Lodge was built as a meeting hall (680 square feet) and therefore readily lends itself to adaptive re-use as additional Town Hall meeting space and other community functions; and

Whereas the Caledon East United Church is willing for the Town of Caledon to relocate the Orange Lodge for community use, but requires a firm commitment from the Town to do so in order not to jeopardize an alternative, time-limited offer of free demolition; and

Whereas preliminary cost estimates for the relocation and rehabilitation of the Orange Lodge to Town Hall campus range from \$150,000 to a maximum of \$250,000;

That staff are authorized to incur costs in the amount not to exceed \$50,000 to immediately temporarily relocate the Orange Hall to the Town Hall Campus; and

Therefore be it resolved that in principle the Caledon East Orange Lodge be moved to a location adjacent to Town Hall for public re-use; and

Further that a new capital project for "Caledon East Orange Lodge relocation to Town Hall campus and renovation" up to a maximum of \$250,000 be added and funded from the tax levy; and

Further that the relocation of the Caledon East Orange Lodge to Town Hall campus be subject to the funding of the "Town Hall Campus Long-term Plan' and confirming its location be considered in the first phase of that Plan; and

Further that a report be brought to Council as soon as possible defining costs, usage, location and other relevant factors pertaining to the relocation and rehabilitation of the Caledon East Orange Lodge.
