Leo Butko, Manager of Regulatory and Inspection Services presented the following information:

Sign By-law

Special Sign Districts (BIA Area, Core Area of Caledon East)

- Discussion on Special Sign District Guidelines
 - O Guidelines are not enforceable require clear criteria for enforcement
 - Regulatory Authority Planning Act, Heritage Act (can we enforce provisions through a Permit process or have specific details captured in the Sign Bylaw?)
 - o Flashing/neon signs

- Agri-Tourism/Artisans, Directional Signs, Temporary/Seasonal Roadside Advertising and Directional Signs
- Sign pollution finding the balance between sign pollution and good and effective advertising methods

Election Sign By-law, Issues

- The By-law can be confusing as to where signs can be placed due to some subjectivity i.e. obstructions
- Difficult to clearly articulate and communicate, leading to misunderstanding of the rules especially by volunteers
- Enforcement resources involved due to misunderstanding of rules
- Enforcement issues with proving of violations i.e. where is the property line?
- Lacking in definition
 - What is an election sign? (vehicles, trailers, etc.)

Councillor Thompson assumed the role of Chair.

Guiding Principles

- The democratic process shall allow candidates to promote themselves through election signs
- The Public has a right to promote their candidates of choice through election signs
- There should be fair and equitable opportunities for all candidates for this promotion
- This promotion through election signs should be balanced with the public tolerance of the aesthetic impact on their community for a limited period of time
- The legislation should be simple, clear, fiscally responsible and easily enforceable.

How to Balance Needs?

Volume of Election Signs

Private Property

Current By-law

- Any number of signs may be placed on private property
- The restrictions are size (1.5 square metres) and height (maximum 2.4 metres)
- Cannot impede traffic, pedestrians or constitute a hazard or safety concern.

Discussion

• Should there be limitations on the number of signs placed on Private Property i.e. one or two signs for each candidate?

Road Allowances

Current By-law

 Election Signs are not allowed on Town Road Allowance except if the election sign would be visually obstructed, then one sign per candidate can be placed on the abutting road allowance with consent of the abutting property owner.

Discussion

- This is Town Property and the abutting property owner has no legislative rights
- Should the status quo be maintained?
- Should all property owners regardless of obstruction be allowed to promote a candidate on the Town Road Allowance?
- Should the Town prohibit all Election Signage on Town Road Allowance?
- Can we consider designated areas where they can be placed on Town Road Allowances?

Size of Election Signs

Current By-law

Campaign Office Headquarters

 An election sign that is a wall sign may not exceed 30% of the wall area for all wall signs.

On Private Property

Not to exceed 1.5 square metres and maximum 2.4 metres in height

On Road Allowance

Not to exceed .5 square metres with a 1 metre in height

Discussion

- Should there be status quo, less or further restrictions on size of election signs?
 These sizes were previously identified as standard sizes following past
- These sizes were previously identified as standard sizes following past consultation with council and public input

Length of Impact to Community

Current By-law

- An Election sign may not be erected or displayed prior to the issuance of writs for a provincial or federal election or no earlier than six (6) weeks immediately preceding the day of a municipal election.
- An election sign shall be removed within seven (7) days immediately following 11:59 p.m. of the day of the election.

Discussion

• Any consideration for shortening the time that election signs can be placed?

Poster Sleeves on Municipal Posts

Current By-law

- Captured in By-law to meet Case Law decision that Municipality provide for signage.
- Town has 17 post locations strategically placed for insertion of election sign sleeve.
- Anecdotal evidence suggests that this option has rarely if ever been utilized

Discussion

• Should this section of the By-law be removed if other means of meeting requirements are accepted

Definitions and Additional Prohibitions

Clarity of definitions

- Provide comprehensive definitions to address concerns:
 - o "election sign",
 - o "mobile or trailer signs",
 - o "vehicle signs used as electoral promotions"

Additional Prohibitions

• Consider prohibiting the use of "Mobile or Trailer Signs" and limits on advertising of election signs on vehicles and where parked.
