# STAFF REPORT 2016-64 RE: PUBLIC SECTOR NETWORK (PSN) UPDATE AND NEW AGREEMENT AUTHORIZATION

That the Mayor and Clerk be authorized to execute the Public Sector Network Agreement between the Region of Peel, City of Brampton and City of Mississauga for the build and operation of a fibre optic network for an initial term of ten (10) years with a ten (10) year renewal option.

# PERMITTING HENS WITHIN RESIDENTIAL AREAS

Whereas hens can provide many benefits, including improving food security, decreasing greenhouse gas emissions related to the transportation of food, and contributing to a just and sustainable food system; and

Whereas hens contribute to the local and affordable production of nutritious food, and support a sustainable food system for the Town; and

Whereas the Town's Regulation and Keeping of Animals By-law prohibits the keeping of hens on any residential lot within the municipality;

Now therefore be it resolved that staff investigate the feasibility of permitting hens within residential areas on properties larger than an acre for the purpose of household egg consumption.

### **LOBBYIST REGISTRY**

Whereas section 223.9 of the Municipal Act, 2001 provides municipalities with jurisdiction to establish a lobbyist registry and to appoint a lobbyist registrar to provide transparency about persons who lobby municipal public office holders; and

Whereas a lobbyist registry records or regulates communications between public office holders and those who engage in lobbying activities by tracking communications between them and making this information available for public inspection; and

Whereas Lobbying is a legitimate and legal activity that is part of an individual's, group's or company's right to communicate with their elected government officials and municipal staff; and

Whereas the purpose of the Lobbyist Registry is to enhance the transparency and integrity of business conducted at the Town of Caledon; and

Whereas the Region of Peel is investigating the implementation of a lobbyist registry;

Now therefore be it resolved that staff investigate and report back regarding establishing a lobbyist registry at the Town of Caledon in accordance with section 223.9 of the Municipal Act, 2001; and

Further that a copy of this resolution be provided to the Region of Peel, the City of Mississauga and the City of Brampton for information.

This matter was recommended to Town Council for consideration of adoption at its meeting to be held on May 24, 2016.

The General Committee recommends adoption of the following recommendation:

# **URBAN FORESTS AND STREETSCAPES**

Whereas growing development pressures within the Town of Caledon may impact the growth and sustainability of the urban forests and streetscapes, in addition to the emerald ash borer devastation of the ash tree population.

Whereas 45 percent of Peel Region urban canopy is located on residential property; residents are therefore the most influential stewards of urban forests.

Whereas the urban forest provides human health benefits and healthcare savings by reducing local air pollution and playing an important role in climate change.

Now therefore be it resolved that staff review the Town's urban forest strategy with that of the Region of Peel and investigate the feasibility of enacting an urban tree by-law to protect and sustain the urban forest within the settlement area of the Town and report back.

### **WALK FRIENDLY COMMUNITIES**

Whereas WALK Friendly Communities is a recognition program that encourages municipalities to create and improve spaces and places to walk by awarding Bronze, Silver, Gold or Platinum designations; and

Whereas the program uses a comprehensive framework of indicators for walkability, that the Town of Caledon can use as a benchmark to encourage community planning and design and targets for ongoing improvements; and

Whereas the Town of Caledon's Parks and Recreation Visioning Plan identifies a vision that provides accessible and sustainable parks, recreation and cultural services that engage everyone and fosters healthy lifestyles and environments while connecting the community and embracing its diversity; and

Whereas an objective of the Town of Caledon's Parks and Recreation Visioning Plan places emphasis on promoting and improving community walkability, livability and accessibility;

Now therefore be it resolved that staff investigate the feasibility of pursuing a WALK Friendly designation and report back for consideration.

This matter was recommended to Town Council for consideration of adoption at its meeting to be held on May 24, 2016.

The General Committee recommends adoption of the following recommendation:

## STUDENT TRANSPORTATION OF PEEL REGION (STOPR)

Whereas Student Transportation of Peel Region (STOPR) is considering the adjustment of the school bus eligibility for St. Nicholas Catholic Elementary School that may impact approximately 113 students based on their assessment and review criteria of the area; and

Whereas the cancellation of the school bus service may result in more students walking to school where public transit is not an option; and

Whereas the intersection at Harvest Moon and King St./Coleraine Drive is not ideal for children to cross as it has been identified as the Bolton Arterial Route (BAR). Due to the speed and the high volume of traffic including goods movement traffic it is not recommended for students to walk along this route; and

Whereas the Bolton Arterial Route (BAR) was designed to remove high volumes of truck traffic travelling through the community and reroute them on to the BAR which is reflected in the increase in traffic from 600 vehicles per hour to 1400 vehicles per hour as indicated by the Region of Peel;

Now therefore be it resolved that STOPR be requested to retain busing for kindergarten to grade 8 students for St. Nicholas Catholic Elementary School; and

Further that a copy of this resolution be forwarded to the Peel Catholic District School Board Trustee, Frank DiCosola and STOPR.

### PRESENTATION REQUEST - BEAUTIFICATION PROJECT FOR CALEDON EAST

That the Caledon East Revitalization Committee (CERC) be invited to a Council meeting to provide a presentation regarding Beautification Projects.
