DELEGATIONS

3. Dale St. Clair provided a delegation regarding the Cheltenham Badlands. He expressed concerns with the proposed accessible parking space, and advised that in his opinion, the proposed location of the parking space is contrary to traffic regulations. He emphasized that the accessible parking space should be located in the parking lot. He explained that it is his understanding that legislation indicates that every parking lot must have an accessible parking space. He expanded on other issues such as the pedestrian walkway, the need for a bike lane, and general challenges with information sharing between committees and Council.

1. Kathy Hering, Manager, Acquisitions and Conservation Services, Ontario Heritage Trust and Serguei Kabanov, Project Manager, Region of Peel re: Cheltenham Badlands.

Kathy Hering provided a presentation regarding Cheltenham Badlands. She provided an overview of the evolution of the land and master planning process for the Cheltenham Badlands Project. She highlighted that the plan focuses on four (4) key principles. Ms. Hering advised that the Ontario Heritage Trust is looking to gain additional feedback from the public and from both the Town and Region of Peel's Accessibility Advisory Committees. She confirmed that the Ontario Heritage Trust has retained the services of an accessibility consultant.

Serguei Kabanov, Project Manager, Region of Peel provided background information concerning the project, highlighting the Region of Peel's partnership with Ontario Heritage Trust. He provided an overview of the proposed design of the off-street parking area. He provided information related to the on-street accessible parking space and walkway, advising that the Region recognizes the need to provide accessibility for the site. Mr. Kabanov highlighted the limitations and constraints of the site and finally, the 2017 project schedule. Members of Council asked a number of questions and received responses from the presenter.

He further advised of new requirements in the Development Charges Act related to the annual treasurer's statement, asset management, and finally, notice requirements and timing.
