PRESENTATIONS

- Michelle Veinot, Director, Community Services, Caledon Community Services provided a presentation concerning the Exchange Collaborative Data Project. She provided an overview of the data collected, findings and implications with respect to social issues in Caledon. Ms. Veinot identified key themes for a collaborative agenda: isolation, access, mental health, prevention and system transformation. She requested that the Town synergize and partner with the Exchange on collaborative work such as youth initiatives.

Members of Council asked questions and received responses from the presenter and staff.

Mayor A. Thompson thanked Ms. Veinot for her presentation.

With the permission of Council, the order of business for the meeting was altered to consider the presentation from North Peel Community Church regarding Black History Month.

- Kevin Junor, Revered Ronald Kelly and Nicole Jeffrey from North Peel Community Church provided a presentation regarding Black History Month. Reverend Kelly recognized Black history as Canadian history. The presenters identified trailblazers of the past, accomplishments of today and opportunities of youth success for the future. They outlined various Black History Month activities at the Church. Mr. Junor noted challenges for Black residents of Canada, the need for local efforts and encouraged Council to partner on community initiatives.

Members of Council asked questions and received responses from the presenters.

Mayor A. Thompson thanked Mr. Junor, Reverend Kelly and Ms. Jeffrey for their presentation.

Councillor A. Groves left the meeting from 9:10 p.m. to 9:22 p.m.

- Kren Clausen, Representative of the Owner, JCKNG Holdings, Corp. and Clare Riepma, President, Riepma Consultants Inc. provided a presentation concerning the Development Charges, J.C. Mini Storage, 7865 King Street. Mr. Clausen provided an overview of the self-storage business and plans for J.C. Mini Storage to expand by 50%. Mr. Riepma provided further information regarding the property history, land use, zoning and taxation. They requested that Council waive the development charges for the expansion and consider the use as industrial for tax purposes.
