	 I am not a person who is not an employee of the Town of Caledon but who is the clerk, Treasurer, Integrity Commissioner, Auditor General, Ombudsman or registrar referred to in section 223.11 of the Municipal Act, 2001 or an investigator referred to in subsection 239.2 (1) of Town of Caledon, or a person who is not an employee of the Town of Caledon but who holds an administrative position of the Town of Caledon.
	I am not a judge of any court.
	• I am not a member of the Assembly as provided in the <i>Legislative Assembly Act</i> or of the Senate or House of Commons of Canada or, if I am such a person, I will provide proof of my resignation in a form satisfactory to the Clerk of the Town of Caledon prior to 2:00 p.m. on Nomination Day, August 19, 2022. I understand that the Clerk of the Town of Caledon will reject my nomination for the above-mentioned office if I fail to provide proof of resignation by this deadline.
	• I am not a public servant within the meaning of the <i>Public Service of Ontario Act, 2006</i> , or if I am a public servant, I have followed and will continue to follow all the relevant provisions of Part V of such Act.
	• I am not a Federal employee within the meaning of the <i>Public Service Employment Act</i> , or if I am a Federal employee, I have followed and will continue to follow all the relevant provisions of Part 5 of such <i>Act</i> .

- 5. I am not prohibited from voting at the municipal election under subsection 17(3) of the *Municipal Elections Act, 1996.*

I am not a person who was convicted of a corrupt practice under the *Municipal Elections Act*, *1996* or of an offence under the *Criminal Code* (Canada), in connection with an act or omission that relates to an election to which this Act applies and I am not a person who is ineligible to be nominated for, any office until the next two regular elections have taken place after the election to which the offence relates (section 91 (1)).
- 7. I am not ineligible from being elected to or holding office by reason of any violations of the election campaign financial requirements or violations for not filing the financial statement pursuant to the *Municipal Elections Act, 1996.* (section 88.23)
- 8. I acknowledge that I have not filed a nomination for more than one office governed by the *Municipal Elections Act, 1996* at the same time anywhere in Ontario. 2001, c. 25, s. 261 (1).
- 9. I acknowledge that Third party advertising is separate from my candidate campaign, and must be done independently from me. Any advertisements or materials that are made and distributed by me, or under my direction, are part of my campaign.
- 10. I am not registered as a Third Party Advertiser.
