## Municipal Class Environmental Assessment for Tamarack Subdivision Drainage Issues


#### THE STUDY:

The Town of Caledon has initiated a Schedule 'B' Municipal Class Environmental Assessment Study to identify solutions to address drainage issues in the Tamarack Estates subdivision.

The Tamarack Estates subdivision is located at the headwaters of the Humber River watershed. The Study is being undertaken to investigate feasible alternative solutions to address the current drainage issues. Field investigations will be required to adequately evaluate the alternative solutions. Permission to enter agreements with landowners in the Tamarack Subdivision will be requested to complete the field investigations.

### **MUNICIPAL CLASS EA PROCESS:**

The project is being completed as a Schedule "C" project in accordance with the Municipal Class Environmental Assessment (October 2000, amended in 2007, 2011 & 2015). As such, extensive public and technical agency consultation will play a key role in developing the study recommendations.



#### WANT TO GET INVOLVED:

Public Participation will form an integral part of the Schedule 'B' Class EA Study to ensure that the ongoing concerns of the public and affected groups within the study area are identified, documented and assessed. A public information centre (PIC) will be held and advertised in advance to enable the public to meet the project team, and to provide feedback to better address the needs and opportunities of the study corridor. The PIC is anticipated to be held in Fall 2019. Further Notice will be provided prior to the PIC.
