

# Bill 112 : An Act to provide for the dissolution of the Region of Peel

# Highlights of the Legislation

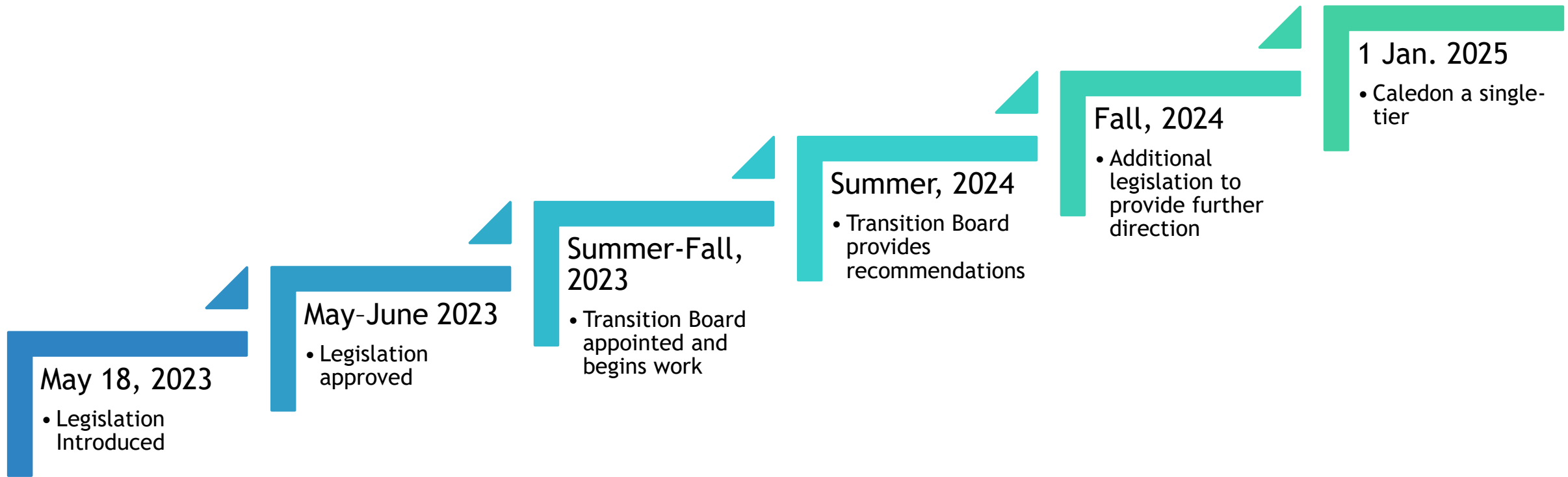
Dissolves the Region of Peel effective January 1, 2025.

Creates a regulation-making authority to manage issues related to the transition.

Establishes a transition board

Intention to bring forward additional legislation in Fall of 2024 to resolve remaining issues associated with the transition

Audit will continue as planned

# Role of the Transition Board

Providing recommendations to the Minister regarding:

- Winding down the financial operations of the Region of Peel
- Transferring of assets, assigning liabilities, debt and other financial obligations of the Region of Peel
- Employment matters
- Allocation and governance of the services provided by Peel
- Impact on any municipality that may be affected by this and the long-term economic sustainability of the Town of Caledon, City of Brampton, and City of Mississauga as single-tier municipalities
- Any other matters that the board considers advisable or the Minister directs

Monitor the actions and decisions of all four Councils and their local boards; including members of committees, staff or officers of the municipality

- May overturn a decision if determined to be contrary to the best interests of the future state

# Responsibilities of the Town of Caledon



Financial compensation of the Transition Board and any support required



Co-operation with the transition board and its employees and agents

Including, but not limited to, providing copy of any documentation or information requested
