



### **The Corporation of the Town of Caledon Model Waiver and Release**

I am the author of any or all of the photographs or images I submit to The Corporation of the Town of Caledon (the "Town"), and I hereby expressly, irrevocably and without restriction waive, in favour of the Town, all Moral Rights with respect to the photographs or images I submit and this waiver may be invoked without restriction by any person authorized by the Town to use the photographs or images I submit. In this Waiver of Moral Rights, "Moral Rights" has the same meaning as in the Copyright Act, R.S.C. 1985, c. C-42, as amended or replaced from time to time and includes comparable rights in applicable jurisdictions.

I hereby grant to the Town an unlimited and irrevocable license to do the following with respect to any photographs or images I submit: (a) the Town may make, display, distribute, modify and authorize the making, display, modification, distribution of photographs and other reproductions of the photographs or images; (b) the Town may use such reproductions or modified reproductions for any Town-related purpose, including the creation of calendars for sale to the public, advertising, educational and promotional materials, brochures, books, flyers, postcards, print, broadcast, film, electronic, and multimedia publicity; (c) the Town may edit the photographs or images containing my image or submitted by me and to add to, delete from, alter and otherwise combine my image with other content in any manner and in any media whatsoever, and that I shall have no claim for any reason against the Town for any such use.

I agree that I will receive no financial compensation of any kind in exchange for any photographs or images I submit or for the use of the photograph(s) containing my image by the Town. I understand my photographs and images may be sold to the general public for financial gain and that any financial gain will accrue only to the Town to be used at the Town's sole discretion with no input or consultation with me.

I warrant to the Town that I am the sole owner of the photographs or images I submit to the Town and I have full authority to assign these rights and interest to the Town. I hereby release the Town, its employees, agents, and any outside third party interests from any claims of liability by me arising from the use of the photograph(s) containing my image and my participation in the production of the photograph(s).
