- 2. Introductions were made.
- 3. The purpose of the meeting was to provide an overview of the McLaughlin Road and Spine Road Municipal Class Environmental Assessment (Class EA), with a focus on the archaeological assessments, cultural heritage assessments and natural heritage.
- 4. Wood presented the material with the assistance of a printed slide deck. A copy of the presentation is attached for reference.

5. FS began by identifying that the Town's project site is within MCFN's traditional territory.

 DOCA handles the triage of over 200 requests / notices a month. As part of this triage process, the MCFN assesses the information based on the type of project, proposed activities, and potential for impacts. Where there are concerns, MCFN will want to meet to discuss.

7. The type of information that MCFN seeks upfront is any existing environmental (aquatic, terrestrial, plant, ecological, land classification) or archaeological studies. Drafts of the archaeological and other reports would be appreciated so that they can identify any comments prior to completion.

- 8. There are expectations of participation by FLRs essentially the FLRs are there when there are boots on the ground. Two FLRs are always sent out for safety and security. The main purpose for the presence of field liaison monitors is to have eyes on the ground, represent their community's voice, and ensure that work is conducted in manner that meets their expectations. FLRs participate alongside consultant. The proponent is expected to cover the costs of the FLRs (rate, per diem, mileage) but that MCFN has the necessary insurance and WSIB coverage. The terms and contract provide the details; MCFN can develop a budget in collaboration with consultants. For archaeological work, this includes all Stage 2, 3 and 4. For environmental work, this includes all types of fieldwork.
- 9. MCFN goal is to sit down with municipalities to build relationships and be part of the process for planning and development projects (such as Official Plans and Amendments, Class EAs). Notices are not consultation.
- 10. MCFN looks at potential impacts during the environmental assessment phase as well as construction and restoration. For large, long-term projects, cumulative effects are also considered. Construction and post monitoring FLR participation is also expected for large projects and / or where concerns are identified.

Summary of Project

- 11. Wood provided a summary of the project and the history of the area. The following key points were identified:
 - a. A key driver for the Class EA is the Mayfield West Phase 2 development (MW2);
 - b. MW2 is projected to accommodate 16,138 residents and 4,449 jobs;
 - c. A new E / W Spine Road is needed to service the new development;
 - d. Study has been expanded to include details associated with the connection of the Spine Road to the Hurontario Street / Valleywood Boulevard / Highway 410 interchange;
 - e. Stage 1 Archaeological Assessment completed and recommended a Stage 2, which will be completed during detailed design.

f. Seven heritage resources were identified in the study area, with 3 resources affected by the proposed works. Supplemental study is required for the interchange modification area;

- g. A Natural Environment study was completed, and some of the study area contributes to Fletcher's Creek, which is inhabited by Redside Dace. The balance of the study area is contained within the Etobicoke Creek watershed.
- h. Terrestrial Habitat survey observed Butternut, Wood Thrush and Eastern Wood-Pewee, and Barn Swallow.
- 12. The Town identified that the plan is to submit the Class EA for public review on June 1, 2019 and finalize by July 2019. Once the Environmental Study Report (ESR) has been filed with the Ministry of Environment, Conservation and Parks (MECP), the Class EA is complete. Ministry of Transportation (MTO) will then take over the project and begin detailed design and construction. The interchange is projected to be built by 2025 and Spine Road (built by developers) by 2021. FS identified that if there are any economic development opportunities, MCFN would be very interested.
- 13. There is a lot of uncertainty with what is happening in the GTA West corridor, which will have an impact on Mayfield West and the entire Town.
- 14. The Town has heard concerns about the lack of transit and difficulty commuting for employment due to the lack of transit. MW2 will be serviced by Brampton transit (in discussions, not finalized). There is a transit stop proposed in MW2. Metrolinx is also looking at creating a GO station in Bolton, using the existing rail line, but this is long term.
- 15. SK asked which Municipalities have successfully consulted with MCFN. FS responded that municipalities of Mississauga, Hamilton, Oakville and Peel Region have all been open and willing to engage.
- 16. SK noted that Caledon's Mayor has a good relationship with MCFN's Chief.

17. Prior to the meeting, the Stage 1 Archeological Assessment was sent to MCFN. During the 30-day review period of the ESR, the Stage 1 Archeological Assessment will be resent to MCFN.

18. MCFN requested to be notified prior to the Stage 2 Archaeological Assessment and stated that MCFN field liaisons must be present during any fieldwork. Town agreed to include a commitment in the ESR stating the requirement for a field liaison to be present during any fieldwork for archeological purposes.

Proposed commitment:

The Town of Caledon and specifically this Study Area falls within Traditional Territory of Mississaugas of the Credit First Nation. As such, the Ministry of the Environment, Conservation and Parks has delegated procedural aspects of the duty to consult to the Town of Caledon as part of the Class EA. Based on the Town's relationship with MCFN, the Town is committed to ensuring involvement of MCFN's Field Liaisons Representatives in any fieldwork associated with future stages of this Project. The Town will work with the Proponent responsible for the detailed design stage to ensure that this involvement occurs during detailed design activities, such as Stage 2 Archaeological Assessment and further natural environment assessments.

Town of Caledon Street Naming

- 19. Following a discussion on street naming, MCFN identified interest in naming Spine Road an Anishinaabe name. KM is on the Region of Peel Street Naming Committee and identified the various naming requirements / criteria.
- 20. KM suggested that FS provide a list of names to KM and KM will filter based on requirements and will submit the remaining names to the Committee.

Municipal Class Environmental Assessment for Widening of McLaughlin Road and Construction of new East-West Spine Road (Mayfield West Phase 2)


The Study

In September 2016, the Town of Caledon initiated a Class Environmental Assessment (EA) for the widening of McLaughlin Road from Mayfield Road northerly approximately 1700 metres and the construction of the new eastwest Spine Road from Hurontario Street to Chinguacousy Road. The notice of study commencement was issued on September 22, 2016.

Based on input provided by key stakeholders, the study area has been extended to include the Highway 410 interchange with Hurontario Street/Valleywood Boulevard. Modifications to the interchange are necessary to maintain and accommodate the operation of the proposed Spine Road intersection with Hurontario Street/Highway 410 and the projected traffic volumes in the area.

The approximate limit of the original and extended study area is illustrated on the key plan.

The requirement for the EA Study has been triggered by the network requirements set out in the approved Mayfield West Phase 2 Transportation Master Plan (MW2-TMP) which fulfilled the requirements of Phases 1 and 2 of the Municipal Class EA process. The Town is proceeding with Phases 3 and 4 of the Municipal Class EA process. The MW2-TMP was a comprehensive transportation strategy accommodating both vehicular traffic and provisions for the pedestrian/cyclist communities.



The Process

The study is being conducted in accordance with the requirements for Schedule "C" projects as outlined in the Municipal Engineers Association's Municipal Class Environmental Assessment (EA) document (October 2000, as amended in 2007, 2011 and 2015), which is approved under the *Ontario Environmental Assessment Act*.

The Class EA process has included public and agency consultation, an evaluation of road improvement alternatives, an assessment of the potential environmental effects of the proposed improvements and identification of reasonable measures to mitigate any adverse impacts. Evaluation of alternative designs for the widening of McLaughlin Road and construction of the East-West Spine Road and the potential environmental effects within the extended study area, including additional input from the agencies has been completed and the results of the studies will be presented at the Public Information Centre (PIC). The purpose of the PIC is to present various alternative designs and the preferred alternative, and to receive public comments. Representatives from the Town of Caledon and Wood will be present at the PIC to answer questions and discuss next steps in the study. The PIC will be held in an open house format, with no formal presentation and has been scheduled for:

Upon completion of the study, an Environmental Study Report will be submitted to the Ministry of the Environment and Climate Change and made available for public review for a period of 30 days. Subject to comments received and the receipt of necessary approvals, the Town intends to proceed with the detailed design and construction of this project.
