RE: St. Marys Cement Inc. (Canada) - Caledon Pit/Quarry (Licence No. 626600) Aggregate Resources Act Licence Application – Class A Licence Part of Lots 14-18, Concessions 3 & 4, Town of Caledon, **Regional Municipality of Peel OUR FILE 8816AF**

On February 1, 2023, an Aggregate Resources Act (ARA) licence application for the proposed Caledon Pit/Quarry on the lands legally described as Part of Lots 14-18, Concessions 3 & 4, Town of Caledon, Regional Municipality of Peel was submitted to MNRF. Following this submission, MNRF provided a letter deeming the application complete on February 23, 2023.

Further to MNRF's letter and prior to the 60 Day Notification Period being commenced by St Marys Cement Inc. (Canada), the following was undertaken:

- Peer reviews were completed on behalf of St. Marys Cement Inc. (Canada) for the submitted water report, natural environment report, noise assessment report, blast impact assessment report and air quality impact assessment;
- Obtained current traffic counts to update the transportation impact study; •
- Implemented modifications to the proposed water management system to address initial comments received from the Credit Valley Conservation Authority and to improve the protection for off-site wetlands; and
- Completed the site specific cultural heritage impact assessments for the properties located at 1055 Charleston Sideroad, 1420 Charleston Sideroad, 18501 Mississauga Road, 16667 Mississauga Road and 18722 Main Street.

As a result of the above, please note:

The licence area and extraction area were reduced from 262.0 hectares to 261.2 hectares and 204.0 hectares to 199.5 hectares respectively;

- All of the technical reports, with the exception of the Stage 1-2 Archeological Assessment, were updated;
- The technical recommendations related to agricultural, socio-economics, traffic and archeology have not changed; and
- The technical recommendations related to blasting, air quality, cultural heritage, visual, water, noise and natural environment have been updated. Please note that the cultural heritage technical recommendations from the December 2022 report (Revised July 21, 2023) have been superseded based on the site specific HIA's. Therefore, the ARA site plans only include the technical recommendations from the site specific HIA's. See enclosed letter from WSP dated August 21, 2023.
