On behalf of our client, CBM Aggregates (CBM), a division of St. Marys Cement Inc. (Canada), Glen Schnarr & Associates Inc. (GSAI) is pleased to provide the attached Stage 3 Archaeological Assessments related to the subject lands.

As staff are aware, GSAI has been assisting CBM as the authorized agents to file applications for an Official Plan and Zoning By-Law Amendment under the Planning Act, R.S.O 1990. As part of these processes, Stage 3 Archaeological Assessments have been prepared.

On behalf of CBM, Golder Associates Ltd., now WSP Canada Inc. (WSP), has prepared 30 Stage 1 and 2 Archaeological Assessments, to date, for sites within the preliminary license boundary for the proposed Caledon Pit/Quarry. Of those 30 sites subject to the Stage 1 and 2 Archaeological Assessments, a total of 14 sites were considered to have further cultural heritage value or interest. To that end, WSP recommended a Stage 3 Archaeological Assessment be undertaken for those 14 sites.

As the Town of Caledon and reviewing agencies are currently undertaking their review of the applications, we wanted to provide staff with this additional information for circulation at our earliest opportunity. The Stage 3 Archaeological Assessments for the 14 sites are listed below by "Location" (consistent with the Stage 1 and 2 Archaeological Assessments) and legal description:
