

1. STOP SIGNS AND ALL OTHERS REGULATORY AND WARNING SIGNS TO BE PLACED AS PER THE ONTARIO TRAFFIC MANUAL. 2. "BICYCLE ROUTE" AND "NO PARKING" SIGNS TO BE INSTALLED

PHASE LINE

ON STREETLIGHT POSTS WHERE POSSIBLE. 3. PARKING PROHIBITIONS MAY BE REQUIRED IN THE AREAS OF INTERSECTIONS AND PARK PATHWAYS AND VEHICULAR PARK ENTRANCE LOCATIONS, ON A SITE BY SITE BASIS. AREAS TO BE CONFIRMED BY TOWN ENGINEERING STAFF PRIOR TO INSTALLATION OF SIGNAGE.

4. ALL "NO PARKING" SIGNS ARE TO BE PLACED IN FRONT OF STREET TREES UPON TRAFFIC APPROACH IN THE BOULEVARD. SIGNS PLACED IN LOCATIONS WHERE THEY WILL BE BLOCKED BY TREES WILL BE RELOCATED AT THE CONTRACTORS EXPENSE.

5. STREET TREE PLANTINGS SHALL BE LIMBED UP AND/OR REGULATORY SIGN LOCATIONS ARE TO BE ADJUSTED AS DIRECTED BY THE TOWN, PRIOR TO GRANTING MAINTENANCE PERIOD FOR THE SUBDIVISION.
