## NATIVE SEED MIX AND NURSE CROP NOTES:

- ALL AREAS PROPOSED FOR SEEDING OR HYDROSEEDING TO RECEIVE A MINIMUM 100MM DEPTH TOPSOIL, FINE GRADED AND SEEDED ACCORDING TO OPSS 572. ALL 5:1 OR GREATER SLOPES TO BE SEEDED WITH TACIFIER. SEED AT RATES NOTED BELOW.
- 2. CONTRACTOR TO SOW A NURSE CROP OF OATS (OSC NO.6710) OVER ENTIRE AREA TO BE SEEDED AT A RATE OF 22 KG PER HECTARE.
- AREAS TO BE SEEDED OR HYDROSEEDED SHALL RECEIVE AN APPLICATION OF SEED AT THE RATE OF 34 KG PER HA, IN THE FOLLOWING SPECIES MIXTURE:
- XERISCAPE MIXTURE (OSC NO.8350);
- 25% YARROW (Achillea millefolium) 75% WHITE CLOVER (Trifolium repens)

3. HYDRAULIC MULCH TOBE APPROVED BY THE LANDSCAPE ARCHITECT SHALL BE APPLIED AT THE RATE OF 2100KG PER HECTARE. 4. 
