Being a by-law to amend Comprehensive Zoning By-law 2006-50, as amended, with respect to, Part of Lot 9, Concession 8 (Albion)

Town of Caledon, Regional Municipality of Peel.

WHEREAS Section 34 of the Planning Act, as amended, permits the councils of local municipalities to pass zoning by-laws for prohibiting the use of land or the erecting, locating or using of buildings or structures for or except for such purposes as may be set out in the by-law;
