Licensing Requirements:

- Business Registration
- Articles of Incorporation
- Corporate Profile Report within 60 days of application
- Criminal Record Check including Vulnerable Sector Check dated within 60 days of application for all principals of business
- 14-17 years of age need written consent from guardians to own a vehicle
- Certificate of Insurance on form provided by Town
- Current Valid Vehicle Ownership
- Provincial Drivers Licence
- Mechanical Safety Certificate or Annual Inspection Certificate dated within 60 days of inspection
- A Certificate from an authorized propane inspection station, accounting for appliances and vehicles mechanical fitness (if powered by propane)
- Passing inspections
- Written approval from Regional Municipality of Peel Health Department
- Site plan showing location of vehicle in relation to buildings, driveways, pedestrian ways and parking
- Letter of permission from owner of property to operate on property and access washroom facilities
- Payment of required fee
