### OFFICE CONSOLIDATION OF ZONING BY-LAW 2006-50 FOR THE TOWN OF CALEDON

This document is an Office Consolidation of zoning by-laws applicable in the Town of Caledon. It includes Comprehensive Zoning By-law 2006-50, and all by-laws amending By-law 2006-50 that came into force prior to March 3, 2022. This Office Consolidation has been prepared for reference purposes only. For more accurate information, reference should be made to the original by-laws.

The provisions of Zoning By-law 2006-50 came into force as follows:

- (1) By-law 2006-50 came into force on October 19, 2006 pursuant to Section 34(30) of the Planning Act.
- (2) By-law 2007-62 (a By-law to amend By-law 2006-50) came into force on June 5, 2007 pursuant to Section 34(30) of the Planning Act.
- (3) By-law 2008-122 (a By-law to amend By-law 2006-50, as amended, came into force on December 9, 2008 pursuant to Section 34(30) of the Planning Act.
