- Birth Certificate / Canadian Citizenship / Landed Immigrant / Work Permit
- Certificate of Insurance (on form provided by Town and naming the "Corporation of the Town of Caledon" as an additional insured)
- Location of office must meet zoning provisions of the municipality
- Complete list of vehicles providing calls from your brokerage (by Caledon plate number, including VIN number)
- Complete list of drivers (by Caledon plate number, see attached form)
- Business Name Registration
- If a Corporate Applicant, a certified copy of a Corporate Profile Report dated within 60 days of application
- If the Applicant is a Registered Partnership, a copy of the Registered Declaration of Partnership
- Licence Fee

**Consent** (section 6)

I am the applicant herein and am aware that a search will be made to process my application for a licence and I consent to the Town of Caledon making enquiries to the Ministry of Transportation and the Ontario Provincial Police or any other police department regarding registration of commercial vehicles, and any criminal offence for which a pardon has not been granted.

I hereby acknowledge that the licence is subject to the provisions of Town of Caledon Taxi Owner Licensing By-law 2013-127 and agree to comply with these provisions. The information contained in this application is true and correct. I am the applicant or, where the applicant is a corporation or partnership, I am a person who has authority to bind the applicant.

**Acceptance** (section 8)

I understand that acceptance of the application and the fee by the Town shall not represent approval nor shall it obligate the Town to issue such Licence.

**Insurance** (sections 11, 12)

I understand that I shall give the Town twenty (20) days prior written notice of the cancellation or variation of the Policy and / or file the renewal insurance Policy five (5) days prior to the expiry date of the current Policy.

**Term of Licence** (section 20)

I understand that a Licence is valid until it expires or is revoked, suspended or cancelled.

**Notification of Change** (sections 22, 23)

I understand that I must notify the Licensing Division within seven (7) days of any change in name, address, or any other information and obtain an amended Licence.

**Renewal of Licence** (section 32)

I understand that any Licence renewed more than sixty (60) days after the date upon which it expires shall be subject to a late fee if an inspection is required for the renewal.

**Inspection of Vehicles** (section 61(1))

I understand that if the driver does not attend a mandatory inspection, or a random inspection, the Owner shall pay the missed inspection fee as set in the Town's Fees By-law.
