

THE CORPORATION OF THE TOWN OF CALEDON

BYLAW NO. 2006-19

Being a bylaw to regulate and provide
for licensing of certain exhibitions.

COUNCIL OF THE CORPORATION OF THE TOWN OF CALEDON ENACTS AS FOLLOWS:

1. In this bylaw
 - (a) "exhibition" means a concert or festival or similar event held outdoors at which musical entertainment is provided to an audience whose members have paid a price for admission thereto;
 - (b) "to hold" when used in relation to an exhibition includes to arrange, co-ordinate, give, organize, present, promote or provide and "hold". "held" and "holding" have corresponding meanings;
 - (c) "licensed manager" means the Chief Bylaw Enforcement Officer of the Town;
 - (d) "Licensing Section" means the Bylaw Enforcement Department of the Town.
 2. The Licensing Section shall:
 - (a) receive and process all applications for licenses;
 - (b) issue all licenses when an application is made in accordance with the provisions of this bylaw and has been approved by the Council;
 - (c) maintain complete records showing all applications received and licenses issued;
 - (d) generally perform all the administrative functions conferred upon it by this bylaw.
 3.
 - (1.) An application for a license shall be made on the forms provided by the Licensing Section and each completed application shall be submitted to the Licensing Section accompanied by the license fee in the amount of \$2500.00.
 - (2.) Where an application for a license is refused, the license fee shall be fully refunded.
 4. No person shall hold an exhibition unless a license has been issued under this bylaw therefor.
 5. No person shall emit or permit or cause the emission of noise from an exhibition that is likely to disturb the inhabitants of the Town.
 6. No person shall hold or permit the holding of an exhibition on land abutting
 - a Provincial Highway or a Regional Road.

No person shall hold or permit the holding of an exhibition without providing at least one person for the purpose of directing traffic and maintaining order for each 200 people attending such exhibition.


No person shall hold or permit the holding of an exhibition without providing at least one water closet for each 100 people attending such exhibition.


"9. Any person who contravenes the provisions of this by-law is guilty of an offence."

"10. the provisions of this by-law shall not apply to the following agricultural fairs:

- (a) Caledon Fall Fair sponsored by the Caledon Agricultural Society,
- (b) Brampton Fall Fair sponsored by the Region of Peel Agricultural Society, and
- (c) Bolton Fall Fair sponsored by the Albion & Bolton Agricultural Society."
